#### **About the Bible**

We believe the Bible is the infallible Word of God and the authority for salvation and Christian living. (See II Timothy 3:15-17.)

#### **About God**

We believe that there is one God, who has revealed Himself as our Father, in His Son Jesus Christ, and as the Holy Spirit. Jesus Christ is God manifested in flesh. He is both God and man. (See Deuteronomy 6:4; Ephesians 4:4-6; Colossians 2:9; I Timothy 3:16.)

We believe that everyone has sinned and needs salvation. Salvation comes by grace through faith based on the atoning sacrifice of Jesus Christ. (See Romans 3:23-25; 6:23; Ephesians 2:8-9.)

(See I Corinthians 15:1-4; Acts 2:4, 37-39; Romans 6:3-4.)

#### **About Christian Living**

The supernatural gifts of the Spirit, including healing, are for the church today. (See Mark 12:28-31; II Corinthians 7:1; Hebrews 12:14; I Corinthians 12:8-10.)

## 1. The Applicant

- a. Shall be chartered as, and remain, an autonomous body. It shall be the right of self government under Jesus Christ, including the power to choose or call its cell leaders, elect its official board, and transact any and all business pertaining to its function as a church body .
- b. Shall have the right to use the name ANOC-Country (or with approval by the Board of Apostolic Network of Oikos Cell) and all registered trademarks associated therewith in publications, signs, advertisements, letterheads, and other places not named herein, but that will be mutually beneficial to the cell and to ANOC Int'l , as long as it shall remain in good standing with ANOC Int'l.
- c. Shall have the right to request the assistance of the ANOC Int'l Credentials Committee in filling a pastoral vacancy.
- d. Shall have the right to administer discipline to its members according to the Scriptures, Statutes and Bylaws of ANOC Int'l.
- e. Shall have the right to acquire and hold title to property either through authorized representatives or in its corporate name as a self-governing body.
- f. Shall have the right to operate specialized ministries of ANOC Int'l
- g. Shall have the right to terminate the Fellowship Covenant, without cause, and agrees to notify ANOC Int'l, by certified letter, within seven (7) days of such decision by the church governing body.
- h. Shall have the right to participate in the world missions involvement of ANOC Int'l and to designate funds for the propagation of the Gospel of Jesus Christ.
- i. Shall have the right to representation and participation of all ANOC Int'l camp meetings, seminars, trainings, retreats and conventions.
- j. Agrees to be faithful to the sacred trust of the ministry by diligence, by uprightness in business matters, by ministerial ethics, by self-sacrificing, by purity, by avoiding the very appearance of evil, by cherishing the anointing of the Holy Spirit, even unto death.
- k. Agrees, by the signature of its chief office, to indemnify ANOC Int'l and its officers in any and all matters of public and private liability, including malpractice, or any other matters arising out of the actions of the applicant.
- l. Keeps the first Friday of each month as COVENANT-DAY, a sacred day of fasting, prayers and intercession for all Covenant Partners of ANOC Int'l around the globe.
- m. Shall support the ANOC Int'l and/or National Office with its Board and Director practically and financially through tithes and offerings.

## 2. ANOC International

- a. Shall have the right to terminate the fellowship Covenant for cause, and agrees to notify the applicant, by certified letters, within seven(7) days of such decision by the Credential Committee of ANOC Int'l
- b. The Credential Committee of ANOC Int'l shall have the right to restrain the use of the ANOC Int'l names and associated trademarks in any action of law and in equity in the event the applicant of any time ceases to be a cooperative fellowship.
- c. Shall, while recognizing the sovereignty of the applicant cell, retain authority relative to any and all ministerial credentials issued to cell leaders, supervisors, overseer, and other members of the applicant cell who are credentialed by ANOC Int'l, and such matters will be determined by the ecclesiastical process of the ANOC Int'l Credentials Committee and not by secular law and jurisprudence.
- d. Shall have the right to recommend a person of persons to fill a pastoral/leadership vacancy, upon request from the applicant church's governing body.
- e. Agrees to be faithful to the sacred trust of the ministry by diligence, by uprightness in business matters, by ministerial ethics, by self-sacrifice, by purity, by avoiding the very appearance of evil, by cherishing the anointing of the Holy Spirit, even unto death.
- f. Agrees, By the acceptance of this application, to indemnify the applicant and its officers in any and all matters of public and private liability, including malpractice of any other matters arising out of the actions of ANOC Int'l.
